Dear Sir,

The President of the Alliance of Conservatives and Reformists in Europe has given me the mandate to fulfill all administrative requirements for the registration of the ACRE Party with the Parliamentary Authority. I hereby submit the necessary documents and provide a list of contents of the submission:

1. The Alliance of Conservatives and Reformists in Europe is a European Political Party, registered as a ppeu in Belgium with its' official address at Rue du Trône 4, B-1000 Brussels, Belgium. The organisation has a registered No: 0820.208.739 and uses the acronym ACRE, its logo is attached at **Annex A**.
2. The Alliance of Conservatives and Reformists in Europe ppeu is a conversion from the Alliance of European Conservatives and Reformists (AECR) asbl. AECR operated as a European Political Party registered in Belgium between September 2010 until July 2017 when it was transferred by Belgian Notary into ACRE ppeu. See **Annex B**. Also submitted within Annex B is the latest edition of the Moniteur Belge.

parties. ACRE has 47 indirect (with member party) MEPs, 4 direct (independent) MEPs and therefore counts 51 individual members in total. AECR has 25 Member Parties.

5. ACRE actively participated in the 2014 European Elections and full intends to participate in the 2019 European Elections. see **Annex E** for the 2014 election results.

7. ACRE is affiliated to the European Foundation; New Direction – The Foundation For European Reform fpeu.
8. ACRE has operated as a non-profit organisation since its creation in 2010 and in full compliance with the European regulations governing, rules of procedure and Belgian authorities.
