From 6 December 2023 (6 months prior to the European elections period), European political parties and foundations had to report all donations received on a weekly basis. Subject to compliance controls and applicable data protection restrictions, the Authority published them here as soon as possible, usually within one week after having been informed of them. Since 10 June 2024, only donations above EUR 12 000 have to be reported immediately to the Authority. Others will become available after the annual accounts are submitted in 2025.
