of 30 September 2025

to register Pour le Peuple ('FTP') as a European political foundation

THE AUTHORITY FOR EUROPEAN POLITICAL PARTIES AND EUROPEAN  
POLITICAL FOUNDATIONS,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) No 1141/2014 of the European Parliament and of the Council of 22 October 2014 on the statute and funding of European political parties and European political foundations<sup>1</sup>, as amended<sup>2</sup>, in particular Article 9 thereof,

Having regard to the application received from Pour le Peuple ('FTP'),

Whereas:

- (1) The Authority for European political parties and European political foundations (the 'Authority') received an initial set of application material for registration as a European political foundation under Article 8(1) of Regulation (EU, Euratom) No 1141/2014 from Pour le Peuple ('FTP') (the 'applicant') on 29 August 2025. The application material was submitted through the European political party with which the applicant is formally affiliated,
- (2) Following request for additional information by the Authority in accordance with Article 9(2) of Regulation (EU, Euratom) No 1141/2014, further submissions supplementing that application material were received on 4, 9, 16, 26, 29 and 30 September 2025,
- (3) The applicant submitted documents proving that it satisfies the conditions laid down in Article 3 of Regulation (EU, Euratom) No 1141/2014 as amended, including the standard declaration in the form set out in the Annex thereto, and the statutes of the applicant of

21 August 2025 containing the provisions required by Article 5 of Regulation (EU, Euratom) No 1141/2014,

- (4) Pursuant to Article 9(3) of Regulation (EU, Euratom) No 1141/2014, the standard declaration shall be considered sufficient for the Authority to ascertain that the applicant complies with the condition under Article 3(2)(c) of that Regulation for the purposes of registration,
- (5) As required by the laws of the Kingdom of Belgium, the application is further accompanied by a statement of a competent public authority certifying, in accordance with Article 15(2) of Regulation (EU, Euratom) No 1141/2014, that the applicant has its seat in that Member State and that the applicant's statutes of 21 August 2025 are in conformity with the relevant provisions of law of that Member State,
- (6) The applicant submitted additional documents in accordance with Articles 1 and 2 of Commission Delegated Regulation (EU, Euratom) 2015/2401<sup>3</sup>,

HAS ADOPTED THIS DECISION:

*Article 1*

Pour le Peuple ('FTP') is hereby registered as a European political foundation.

It shall acquire European legal personality on the date of the publication of this Decision in the *Official Journal of the European Union*.

*Article 2*

This Decision shall take effect on the day of its notification.
